EHRs Currently Integrated with Idaho's PDMP As reported in the October 15 edition of IMAgEs (available online at https://www.idmed.org/idaho/Idaho_Public/Communications/Newsletters), the Idaho Division of Public Health has received grant funding to assist providers in integrating the Idaho prescription drug monitoring database (PDMP) into their electronic health records (EHRs) using a product called Gateway. This will reduce the burden on physicians and other prescribers and allow fast lookup of patients' prior and current controlled substance use.

Based on questions from members, IMA contacted the Idaho State Board of Pharmacy (BOP) to determine which EHR systems are currently in production for Gateway integration and which are in the development or testing phase for integration. The BOP provided a list current as of November 1, 2017. As integration work continues, the list is subject to change at any time. The list is available in the "News" section of the IMA home page at www.idmed.org.

Medicaid Payment Reform Plan Aims to Transform Healthcare Delivery, Quality in Idaho As part of the Idaho Department of Health and Welfare's (IDHW) ongoing initiative to transform healthcare delivery and quality through innovative, cost-effective solutions, the Division of Medicaid is developing a plan for payment reform that will build upon the success of the 2016 Patient-Centered Medical Home (PCMH) program.

The Medicaid Health Connections PCMH Tier Incentive Program resulted in approximately 140,000 Medicaid clients – half of the state's Medicaid participants – being served in 180 clinics offering care coordination.

The next step is shifting payments from the legacy fee-for-service, volume-based model to a value-based reimbursement structure that gives these PCMH Healthy Connections clinics an opportunity to earn a share of the savings by improving quality and reducing costs.

"Under this program, Medicaid will set quality measures and a budget for providers who come together to create a new Regional Care Organization, or RCO," said Division of Medicaid Administrator Matt Wimmer. Participant membership in the RCO is based on who the participant picks as their primary care provider.

If the primary care provider is participating in the RCO, the participant is too. All the providers in the RCO will work together to provide better coordinated, higher quality care for those participants.

"Because healthier people tend to use less expensive services instead of more expensive ones – think using primary

care instead of an emergency room or needing to be in hospital – we think this will result in cost savings for the state,” said Wimmer. “If the RCO achieves their performance goals on the quality measures, we will take a look at how they did on their budget. If they saved money, we will share some of those savings with the providers.”

To provide an opportunity for local input and encourage collaboration, each region of the state will have a Community Health Outcome Improvement Coalition (CHOICe) to act as an advisor to the RCO. The CHOICe advisory groups will be tasked with improving whole-person health and wellness in the region by helping to align services and resources.

These advisory groups may be eligible for a portion of shared savings, which will be based on regional performance and will be distributed back to the community through a granting process. These shared savings will be used to fund community initiatives that advance population health.

To develop the Idaho Medicaid payment reform plan, called “Healthy Connections Value Care,” IDHW leaders have been meeting regularly with various stakeholder groups, including the Idaho Hospital Association, Idaho Medical Association, Idaho public health district directors, Employers Health Coalition of Idaho, the Idaho Healthcare Coalition, administrators of major hospital systems, the Community Health Clinic Network of Idaho, various legislators and healthcare providers.

“It has been rewarding to work with physicians and health systems across the state and see their deep interest in this reform initiative,” said IDHW West Region Director Jeff Crouch, who has been sharing the proposal with healthcare professionals, congressional staff and other organizations. “Providers in the southwest region of Idaho are now forming what we expect will be the state’s first RCO, to be launched in July 2018.”
